Terms & Conditions

Preamble

Clause 7 (Nature of legal relation between the two parties)

The two parties declare that the legal relation arising between them isn't an employment relation and that this contract isn't an employment contract. The first party shall not have a supervisory or controlling power over the second party while doing his work and he/she shall be independent while doing his work. Consequently, any of the provisions of labor, suretyship and guarantee laws shall not apply to this legal relation.

Clause 8 (Maintaining Reputation)

Each party shall be bound to maintain the reputation of the other party and the trademark owned by him and not to do any personal acts and not to exercise activities that distort their image, prestige and credibility.

Clause 9 (Confidentiality of Information)

Each party shall be bound to maintain the confidentiality of information related to the other party's project, which is not available publicly to the public, and this includes work mechanisms, obligations, financial rights, account names, passwords, and any other information that is exchanged privately between the two parties or it is agreed that it is confidential or any other information is confidential in naure.

Clause 10 (Rescission of Contract)

1- The contract may be terminated by any party for convenience without a reason, and without need for a court, by providing a 30 days notice.

2-The contract shall annulled by one of the two parties breaches of the obligations imposed under this contract, while the other party retaining his right to demand the necessary compensations in case he/she suffered damage due to the other party's fault, and the annulment shall be effective in case the damaged party notifies the party in breach to implement his obligations under the contract and the party in breach does not implement those obligations within 30 days from the date of the notification, unless the reason for non-implementation is an acceptable legal justification or force majeure.

Clause 11 (Notices)

Each of the two parties declare that he/she has taken an elected domicile whose address is next to the name of each of them at the beginning of this contract and all correspondence, notices and notifications sent to this address or e-mail shall be deemed valid and considered to produce all their legal effects unless either party notifies the other in writing of the change of his address or e-mail.

Clause 12 (Governing Law and Competent Courts)

This contract shall be governed by the laws in force in Qatar and the courts in it shall be competent to adjudicate each dispute arising in relation to the interpretation or the performance of the conditions and obligations in this contract.

Clause 13 (General Provisions)

(1) This contract has been executed in two typical copies each one of which has the same legal effect and each copy is signed by the two parties and each party has received one of them to act accordingly. Any amendment of the clauses of this contract shall be in writing and signed by the two parties to the contract.

(2) In case of contradiction between Arabic copy and English copy of this contract, the Arabic copy shall prevail and result in all its legal effects in relation to the two parties.

(3) The exclusion of any terms and conditions or term of this contract under a judicial decision or imperative legal provision shall not prevent the continuity of performing all the other terms and conditions provided for herein.

(4) The two parties have agreed that in case of contradiction of the terms of this contract with the supplementary legal provisions whose contrary may be agreed upon by the parties, the terms contained herein shall be applied and preferred to the supplementary legal provisions that regulate the issue.

(5) The obligations of the parties shall not be limited to those provided for hereunder but shall be extended to include any other legal provisions that impose obligations on the second party in relation to maintaining the confidentiality of information or noncompetition.
